**A By-law relating generally to Remuneration of Council and Non-Council
Committee Members**

1 INTERPRETATION

- 1.1** The Definitions set out in By-law No. 2011-1 shall apply to this By-law.
- 1.2** In this By-law, unless the context otherwise requires, the singular number or the masculine gender shall include the plural number or the feminine gender, as the case may be.
- 1.3** Each provision of this or any other By-law and any part thereof of the College shall be interpreted in a manner consistent with the RHPA, Code, ASLPA and Regulations, and where an inconsistency is found to exist, and where practical, the inconsistent provision shall be severed from such By-law or any part thereof.

2 CALCULATION OF REMUNERATION

- 2.1 Reimbursement of Expenses.** All members of Council or any Committee of the College shall be reimbursed by the College for expenses incurred in the course of carrying out the business of the College, the Council or Committee, in accordance with the By-laws and the policies of the College.
- 2.2 Procedure for Reimbursement.** The College shall remit any payments provided for in this section to the persons entitled to such payment upon submission to the College of claim forms and receipts, representing the days, or parts thereof, engaged, or expenses incurred, in the course of carrying out the business of the College, the Council or any Committee.
- 2.3 Travel Allowance.** Where a member of Council or any Committee of the College who is a member of the College must travel outside of the community in which the member resides, a travel allowance, which shall consist of a rate for distance traveled per kilometer, or airfare, bus or rail fare, plus transportation to and from air, bus, or train terminals, will be payable by the College.
- 2.4 Travel Stipend.** Where a member of Council or any Committee of the College who is a member of the College must travel more than two hours (one-way) outside of the community in which the member resides to attend a meeting, a travel stipend will be payable by the College in accordance with By-law No. 2011-4.
- 2.5 Meetings and Conferences.** If the Council appoints a member of the College, other than a Council or Committee member, to represent the College at a meeting or conference, the member shall be reimbursed for expenses incurred in accordance with the By-laws, plus registration fees, if applicable. The member shall not accept reimbursement for expenses from any other body.
- 2.6** The public and professional members of CASLPO as set out in the left-hand column shall receive remuneration for services and reimbursement for expenses in the amounts set out in the right-hand column of this By-law.
